ARKANSAS/REGION VI INSTITUTE ACTIVITIES

The AR Institute planning committee met every other month in planning for the 2022 AR/Region VI Institute, The AHSA worked to make the Region 6 conference a success even after checking COVID-19 vaccine cards. The five-state face-to-face institute was held at the Red Wolf Convention Center in Jonesboro, Arkansas. Our theme for the event was "*People, Purpose, and Passion*" *The Pathway to Success*. Arkansas is proud to sponsor the Region VI Institute in conjunction with "one night only" for Arkansas to recognize outstanding EHS/Head Start workers and degreed staff.

It was genuinely exciting to be able to collaborate with HSSCO directors from Texas, Oklahoma, Louisiana, and New Mexico to address Opioid and Substance Misuse on a platform that brings all five states together to learn from each other. This was the pre-event to the institute.

We had dynamic speakers lined up for three dynamic general sessions, approximately 60 small group sessions, and for the first time, we have added a Leadership Development luncheon for all directors and executive directors. Other highlights of the institute included a Head Start T-shirt contest, Silent Auction, Exhibitors, and excellent time for networking and meeting others. The proceeds from our Silent Auction goes to the Arkansas Imagination Library.

The AHSA is already in the planning stage for their state institute. The institute is scheduled for June 6-9, 2023.

AHSA CLASS Meetings

The AHSA meets every other month to plan, coordinate, and network with EHS/Head Start programs through different classes. The classes include directors, staff, parents, and friends. Guest speakers are invited to attend meetings to share updated information that would be of interest to the classes. The AHSA had their first meeting in January for 2023.

The AHSA/HSSCO has completed their strategic plan. This is a five-year strategic plan for the association (2022-2027). The AHSA has also put in place a Strategic Planning Committee to ensure that ALL goals are completed within a timely manner. The plan has identified some actionable goals that will increase involvement in the association and enhance the work that is being done in the local programs around the state. The plan will be reviewed at each AHSA meetings. Other issues that programs have faced include workforce, retention, salaries, and other.

The AHSA is working to build and meet the Dollar per Child for 2023. The Dollar per Child amounts submitted went very well last year! Arkansas is working hard to meet our Dollar per child amount for 2023.
