Reporting Information:

This report reflects the activities and engagement of the TXHSCO since the January 25, 2025 meeting:

PRIORITY 1: Collaborate with state systems to align early care and education services and supports for children and families prenatally to age 5.

Participated in several meetings with the Texas Education Agency (TEA), State PreK, and the Texas Workforce Commission to create a family-facing eligibility screener to finalize the work on developing an Early Childhood Eligibility Screener. The tool will be an online screener that a family can complete to determine which program(s) their child or children might qualify for, along with instructions on how to find programs to apply for Head Start, State PreK, or Child Care.

- The process included a survey of state partners, parents, HS/EHS Grantees, and the Texas Head Start Association Board to provide comments and input. Several volunteers from Head Start, State PreK and Child Care will participate in a focus group to further discuss the eligibility screener.
- The team participated in a meeting with the development of the mobile version of the screener on 3/27 to review and provide comments on the final version of the screener prior to the focus group review/discussions. The final document will be housed on the Early Childhood Texas Website. The launch date is May/2025.

Participated in a quarterly meeting with Children At Risk, PN-3 Collaborative group. The focus was on the Texas PN3 collaborative's goal to support over 400,000 additional infants and toddlers by 2026, emphasizing a whole-child approach with equitable access and aligned systems. Key presentations included policy priorities for supported families by Text Protects, highlighting the need for comprehensive services and increased funding, and for Healthy Beginnings by Texans Care for Children, which focused on maternal health initiatives. The Children's Funding Project discussed Texas' revenue sources and proposed new tax options to improve funding for early childhood programs. The meeting included participant feedback, discussions on political strategies, and forthcoming events such as the March 6th rallies. Action items were assigned for ongoing advocacy and collaboration among participants.

Participated in a quarterly meeting with the Houston Infant/Toddler Coalition to plan for 2025:

- Increase public awareness about promoting early development and support for parents & caregivers, with an emphasis on early relationships & bonding.
- Improve developmental monitoring practices & quality of Early Childhood Intervention (ECI) referrals; support the outreach components of Help Me Grow.
- Develop capacity to ensure a stable, well-trained workforce, with a specific focus on home-based child care.

PRIORITY 2: Work with state efforts to collect and use data on early childhood programs to guide decision-making and improve child and family outcomes.

Participated in Learn the Signs/Act Early Texas quarterly meetings, serving as an ambassador to Texas supporting the data collection for 2025. The Texas Deputy Ambassadors provided information and data regarding their work sharing "Learn the Signs. Act Early" (LTSAE) and Family Engaged Developmental Monitoring (FEDM) Information within their localities, organizations, and coalitions. Act Early Texas continues to offer parents and early childhood professionals valuable information to pinpoint areas where a child's development may differ from their peers, ensuring timely intervention.

PRIORITY 3: Support the expansion of and access to high-quality workforce and career development opportunities for staff.
