My initial goal was to save toward purchasing a reliable laptop, as I plan to pursue my bachelor's degree to become a lead teacher. Unfortunately, my current laptop does not meet the requirements for proctored tests, and I have not yet found an

option within my budget. However, I am exploring ways to contribute additional funds to make this purchase possible.

The reason I began this journey at 38 is deeply personal and meaningful to me. Over the years, I've witnessed instances where some educators did not fully adhere to rules, protocols, procedures, and curriculum. This weighed heavily on my heart and inspired me to return to school. I was once a child in the school system who struggled with a learning disability, and I understand the importance of receiving proper guidance and support.

I have had the privilege of being an assistant for seven years (now entering my eighth), working alongside lead teachers who have poured their hearts into providing children with meaningful education, using every tool and resource available to them. However, I've also observed others who seemed more focused on simply getting through the day, rather than fully embracing the opportunity to enrich children's learning experiences. This contrast has fueled my desire to become a lead teacher who prioritizes creativity, dedication, and excellence. I believe it is our responsibility as educators to utilize every resource available to us and follow the road map provided to guide and inspire the next generation. God willing, I hope to lead a classroom one day and serve as an example of what a committed, passionate educator looks like.

This decision has not been without challenges, as I also have a beautiful family to consider.
